All the students of IIPS are here by informed that they are required to register by paying fees through MP Online. Students shall be considered "Registered" only he/she is eligible for registration and has completed the below mentioned registration process as per the schedule.

Last date is 8 March 2026, after this date late fee will be applicable as per the below schedule.

1. Follow following steps to deposit the fee -

- davv.mponline.gov.in → Click on UTD Section Option → Click on ALL UTDS (IET/SCSIT/ DDE/ IIPS/ IMS /Other) APP. → Deposit Sem Fee / View Receipt → Enter your enrolment no. and deposit the fee using Credit Card / Debit Card / Net Banking / Authorized MP Online KISOK center.

2. **Employee ward-** Students must deposit applicable fees/ portal fees to register themselves in the current semester. **After due date late fee will be charged.**

3. **Education Loan/DD-** Student who will deposit the fees through Education loan must submit the fees on or before last date, **they must submit the acknowledge receipt provided by bank or Fee Receipt provided by the institute**, for updating fee on the online portal and complete the semester registration process by depositing the portal fee through davv.mponline.gov.in.


4. **Scholarship-** Students availing various scholarships (MMVY/MPTAS etc.) have to follow the above mentioned steps to complete the registration process.

Important Note

- Before paying the semester fee of the next semester student should verify the Passing status of the previous semester.
- Students are requested to note down the reference number displayed on the screen before depositing the Fee, It is useful for re-verification of Payment i.e. Fee gets deducted but it is showing payment status as not done.
- Re-verification can be done on the same day only at www.mponline.gov.in through the below link

- Keep patience, in case of transaction failure. Pay again after getting refund.
- Re-verification of payment can be done through www.mponline.gov.in under heading "**For KIOSK/Citizen** → Payment Double Verification"
- Students who deposit the fees through Bank Loan- must submit the acknowledgement receipt of transaction at Database Lab-1 in the prescribed format. Format is available at www.iips.edu.in under the link "Acknowledgement Receipt of Transaction from Bank."
