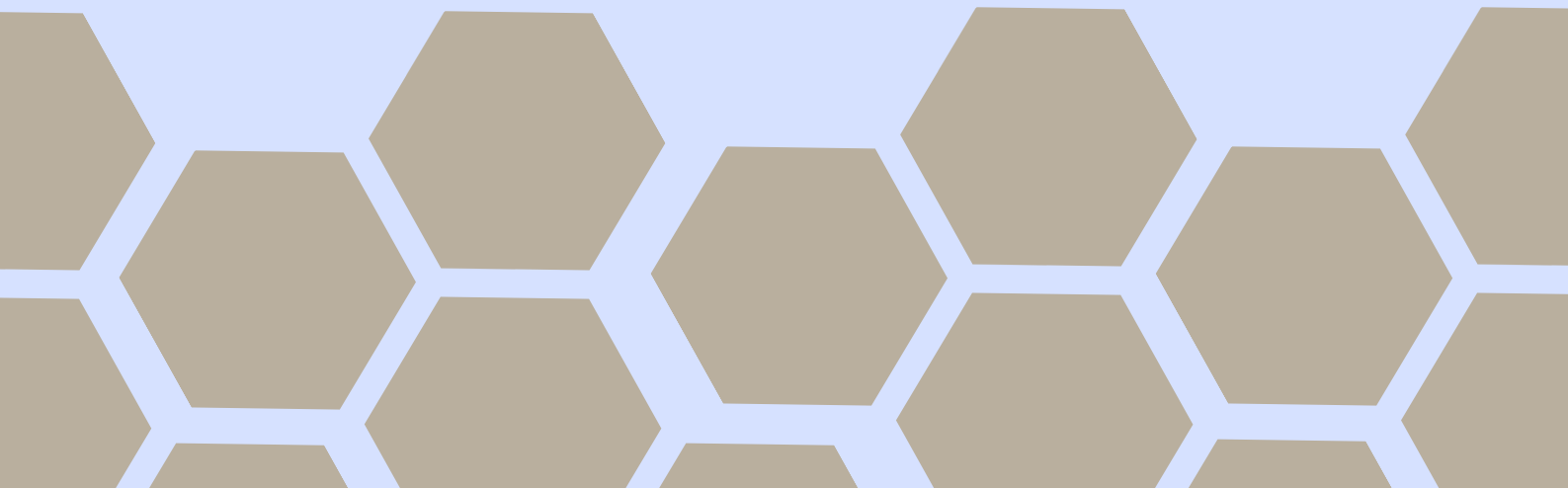

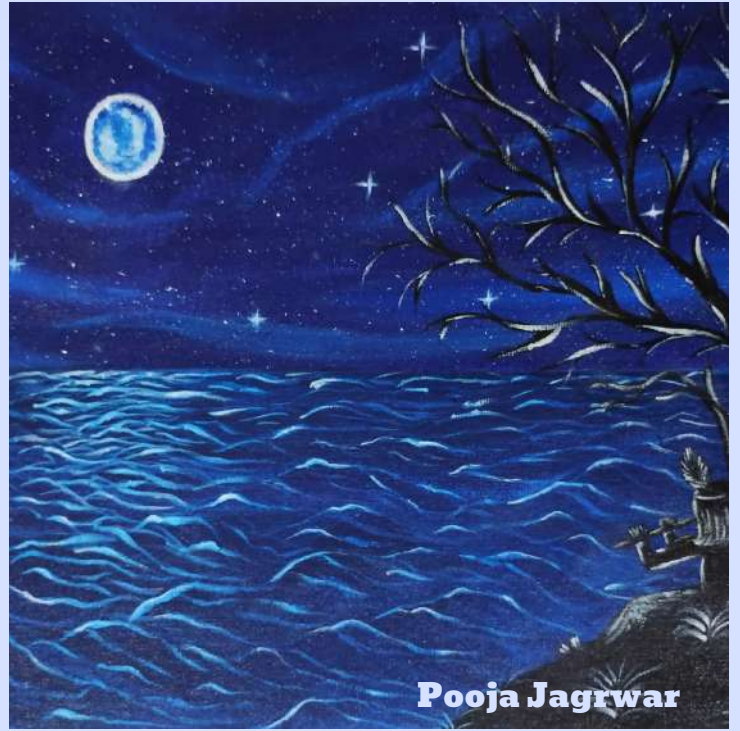

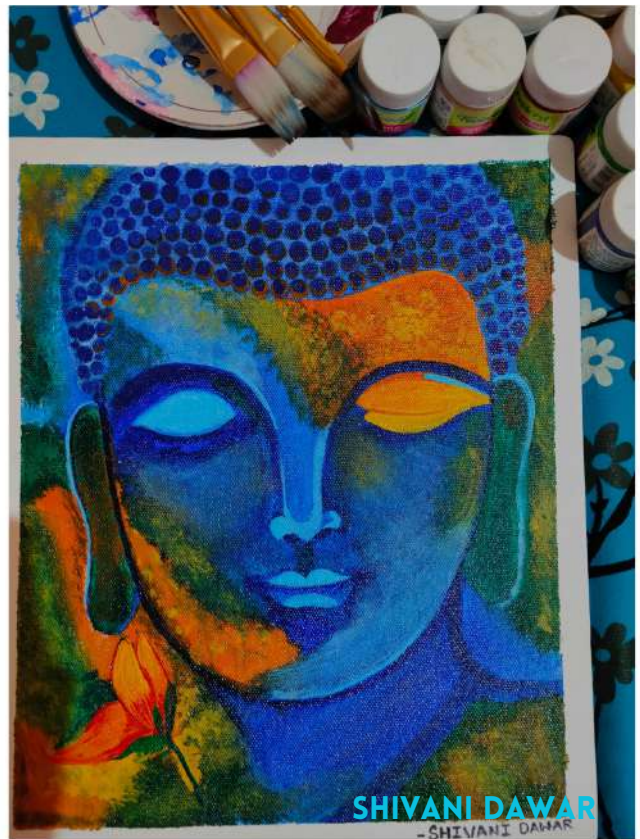

During his tenure at IIPS, he has been instrumental in establishing collaborations with eminent multinational companies and setting up industry-relevant facilities and training centres on campus.

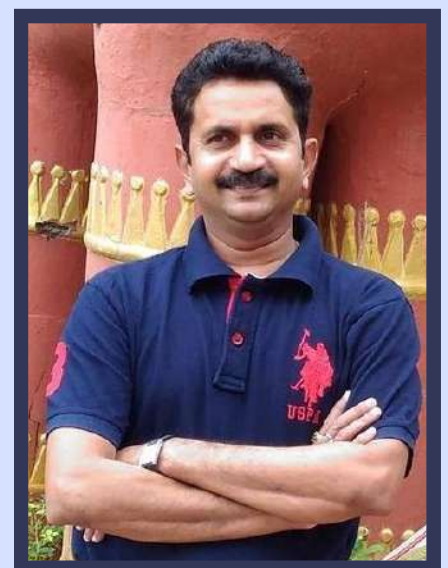
He is committed to making IIPS a centre of excellence and innovation in education and research.
